

Message from the NAME President

“I wish it need not have happened in my time,” said Frodo. “So do I,” said Gandalf, “and so do all who live to see such times. But that is not for them to decide. All we have to decide is what to do with the time that is given us.”

So began last edition’s letter – and the question is, have things gotten any better since? If your office is like mine, the answer is a resounding “no!”

Case numbers continue to rise at an alarming rate – so high, in fact, that many offices are facing challenges to accreditation status, or have simply abandoned the pursuit of accreditation entirely. Along those same lines, any energy devoted to ISO accreditation seems to have dissipated, given that “desirable” is so much less pressing than “necessary.” Case complexity is rising simultaneously depending on your local drug demographics – in

Milwaukee, we have already seen half a dozen “Frankenfentanyl” and the pace of drug design seems to be picking up as those in the trade attempt to stay ahead of legislation and enforcement. The third ingredient in this toxic brew is the clear crisis in forensic pathology staffing. At this point, an office might be granted funding for additional hires, but candidates are nowhere to be found – in fact – they already have jobs, and the process of poaching is well underway (and understandable). On top of this critical shortage, forensic pathology is a relatively “gray” subspecialty; as Baby Boomers continue to retire, the pinch will only become harsher.

While our main issue is survival, we must also consider the opportunities at hand. With our assistance, politicians at every level can perhaps understand that our work is crucial; benign neglect will no longer suffice, and the time for recognition, support, and real funding is at hand. Creative solutions must be proposed and advanced, from student loan forgiveness for those entering forensics to the pooling of scarce resources AKA regional forensic science centers. Simultaneously, we must not give up ground already “captured” – we must continue to stress the importance of full accreditation and a workload (the 250/325 standard) that allows us to minimize burnout and excessive mistakes.

The NAME Foundation has a clear role to play here, centered on encouraging bright students to enter the field, and supporting medical students, residents, and

fellows as they advance. A long-term solution, to be sure, but just as critical as survival during this present crisis. The Foundation “special event” in Scottsdale

will be superb, the topic timely, and the funds raised necessary. I hope to see you there!
