



The NAME Foundation exists to further the discipline of Forensic Pathology and scientific medicolegal death investigation through education and research, and to preserve the history of Forensic Pathology.

The Foundation supports the Best Resident Paper and Poster presentations and Best Affiliate presentation at the NAME annual meeting with awards of \$500 each. The Foundation also provides travel scholarship awards to fellows, residents and students who make presentations at the annual meeting.

Governance of the NAME Foundation is through an elected Board of Trustees (BoT). The trustees are elected from the membership of the Foundation at the annual meeting held in conjunction with the Annual NAME Business meeting. The trustees are responsible for the supervision, control and direction of the management, affairs and property of the Foundation. They determine its policies and changes therein and actively determine its purposes and objectives and supervise the investment and disbursement of its funds.

Membership in the Foundation is conferred by a minimal annual contribution to the Foundation of \$50 by a NAME member and \$20 by a NAME affiliate. NAME members and affiliates may contribute at the time that they renew their NAME membership online or at any other time through the NAME website.

Contributions may be made to a restricted fund used only for support of research and education or to an unrestricted fund, which may also be utilized for building a future headquarters for NAME.
