Get acquainted with the field. Shadow pathologists, investigators and autopsies. As much as possible, try to rotate in at least two different ME offices. Try to go to court and observe. Make sure that you can adjust to doing autopsies for a career and that you are comfortable with testifying.

WHAT IS THE MOST REWARDING ASPECT OF BEING A FORENSIC PATHOLOGIST?

Providing medical information to families that would be useful for survivors.

WHAT IS THE GREATEST CHALLENGE OF BEING A FORENSIC PATHOLOGIST?

The grind of autopsies and the sometimes mentally exhausting aspect of testimony.

WHAT DO YOU THINK ARE THE MOST IMPORTANT ISSUES/CHALLENGES OF FORENSIC PATHOLOGY TODAY?

- 1. Encouraging physicians to become pathologists and forensic pathologists.
- 2. Significant increase in the number of cases.
- 3. Difficulty in recruiting.
- 4. Not enough funding for training.

WHAT HAS BEEN YOUR MOST MEMORABLE CASE AND WHY?

When I was working in Detroit, the Medical Examiner's office was involved, along with the FBI, in the recovery of 1500 anatomic specimens in a warehouse including more than 1000 heads. We classified the specimens, assigned numbers and stored them.

WHAT HAS BEEN THE MOST UNEXPECTED FINDING YOU HAVE ENCOUNTERED DURING A CASE?

In Detroit as well, we performed the autopsies of four young women that were found in the trunks of vehicles in a 2-week span. There was no trauma and negative toxicology. They had only one thing in common, the individual that contacted them on a dating website. It is my opinion that he asphyxiated them. He was convicted.

WHO IS YOUR ROLE MODEL AND WHY?

Dr. Werner Spitz, who I have developed a friendship with and who has shared his immense knowledge and experience with me.

WHAT ARE YOUR HOBBIES AND HOW DO YOU MAINTAIN A WORK-LIFE BALANCE?
