- Performing autopsies and obtaining appropriate specimens for laboratory analysis.
- Performing microscopic analysis when appropriate.
- Determination of cause and manner of death.
- Preparation and completion of reports of findings in a timely manner.
- Review of current literature as necessary to assist in formulation of decisions.
- Provide expert witness testimony in court.
- Teaching of medical students, residents, fellows and law enforcement personnel.
- Consult with prosecution and defense attorneys in preparation for court proceedings.
