San Diego County Medical Examiner's Office



The Medical Examiner's Office provides medicolegal forensic death investigation services for the citizens of San Diego County, as mandated by State law.

Equipped with 17 state of the art autopsy stations spread between 5 autopsy rooms, a neuropathology teaching suite; a dedicated dental and anthropology suite; 2 Mobile Diagnost wDR and a MultiDiagnost Eleva with FD and 3D-RX multi functional xray system, the department has initial jurisdiction over approximately 37% of the deaths in the county, or 8,092 cases, and ultimately transports approximately 98% of those decedents to the department's facility to determine identity, cause and manner of death.

Statistical information for these sudden and unexpected deaths is provided to research institutions and the public, aiding community understanding of health and safety risks and trends. Committed to service, education and research, the department performs scene investigations, autopsies and external examinations, toxicology testing, and administrative support. In addition, the department is accredited to educate future forensic pathologists and pathology residents.

Promote safe communities by certifying the cause and manner of death for all homicides, suicides, accidents and sudden/unexpected natural deaths in San Diego County. In addition, provide related forensic services, assistance and education to families of the deceased, as well as to public and private agencies, in a professional and timely manner.

The San Diego County's Medical Examiner's Office is one of eight California counties accredited by the National Association of Medical Examiners (NAME), which sets national standards in forensic medicine. It is one of three accredited in California by the American College of Graduate Medical Education (ACGME) to educate future forensic pathologists. The Medical Examiner's office provides a modern infrastructure, with innovative technology and appropriate resources. Our Forensic Toxicology Laboratory is accredited by the American Board of Forensic Toxicology (ABFT), performing all of its investigations, toxicology, and forensic pathology in house.

The Position

Chief Medical Examiner

The Chief Medical Examiner for the County of San Diego investigates and determines the circumstances, manner and cause of all sudden, violent or unusual deaths, as well as deaths occurring without medical supervision or when a physician is unable to determine the cause of death. Overseeing the operations of 57 staff, including seven forensic pathologists, and an annual budget of approximately \$12.1 million, the Chief Medical Examiner reports to the Deputy Chief Administrative Officer of the Public Safety Group.

As the Chief Medical Examiner, you will have overall responsibility for:

- Planning, organizing, directing, and evaluating departmental functions, services, work units, and staffing patterns for subordinate staff
- Coordinating work activities with various County departments and external agencies
- Supervising, assigning and reviewing the work of subordinate staff
- Establishing short and long-range plans to meet projected service levels, identify operational problems and formulate appropriate solutions
- Preparing reports and presentations summarizing legal and medical issues and the scope and level of services, revenue sources, fees for services, cost estimates and time projections
- Determining the mode of death and autopsy protocol to establish the cause of death
- Ensuring the preservation of physical and medical evidence and departmental case files in accordance with professional standards and State regulations
- Testifying in court or to the Grand Jury
- Developing annual budget and monitoring revenue and expenditure transactions, conducting fiscal analysis, and preparing cost projections
