The Deputy Medical Examiner conducts death investigations, performs postmortem examinations, supervises support staff, provides expert testimony, assists with office administration, and may serve as acting department head in the absence of the Chief Medical Examiner.

Graduation from an accredited school of medicine and completion of an accredited forensic pathology fellowship training program. Licensing and Certification: Licensed as a physician in Washington State and Idaho State. Must obtain Forensic Pathology Board Certification from the American Board of Pathology within three (3) years of appointment.

About the Office: The Spokane Medical Examiner's Office is a NAME-accredited regional center for performance of forensic autopsies, located in a new state-of-the-art facility which became operational in June 2020. The office serves Spokane County and performs autopsies for several other counties in Washington and the Idaho panhandle, through referral from Coroners and Prosecutor-Coroners.

The Spokane County Medical Examiner's Office employs 4 Forensic Pathologists, an Operations Manager, 2 full-time Administrative staff, 3 full-time Morgue staff, and 7 full-time Medicolegal Death Investigators. All staff members are employed by Spokane County. Investigative staff are available 24 hours a day, 7 days per week, and scene attendance is at the pathologist's discretion. No autopsies are performed on weekends or holidays.
