The Office of the Medical Examiner (OME) within the Denver Department of Public Health & Environment (DDPHE) investigates violent, suspicious, and unexpected natural deaths in the City and County of Denver. As a Forensic Pathologist, you will perform medicolegal autopsies, determine cause and manner of death, provide expert testimony, and support investigations in collaboration with law enforcement, attorneys, and public health professionals. This role also includes mentoring fellows and medical trainees, participating in research, and assisting the Chief Medical Examiner with quality assurance, safety, and policy development.

# **Job Requirements**

- Graduation from an approved school of medicine.
- Completion of post-graduate training approved by the American Board of Pathology.
- Possession of a license to practice medicine in Colorado at time of appointment (or eligibility with application in process).
- Board certification in Anatomic or Anatomic/Clinical Pathology at the time of application.
- Must be eligible to sit for the Forensic Pathology Boards at time of appointment and pass within 18 months of employment.
- Must complete DNA consent form (Denver Police Forensics & Evidence Division) at hire.

#### Workload

- Conduct medicolegal autopsies in accordance with forensic pathology standards.
- Expected autopsy caseload consistent with national averages for metropolitan jurisdictions (exact number may vary depending on case volume).
- Share on-call responsibilities with other forensic pathologists.
- Participate in death scene investigations and provide consultation on forensic pathology cases.
