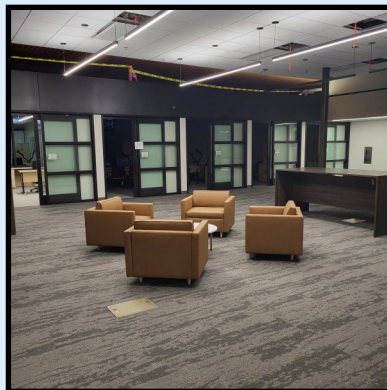

We have a highly trained, well-staffed forensic division of Forensic Pathologists, Forensic Supervisor, Forensic technicians, a 24 hour investigative force of ABMDI registered Medicolegal Investigators, Anthropologist, and a superb Administrative Staff.

The Coroner's Office is NAME and IACME accredited. We are a regional center providing consulting and pathology services to 33 Idaho counties and 3 sovereign nations. Moving forward there will be growth in our office, new technologies and state of the art facility enhancements. This provides a unique opportunity for individuals to help create an environment of progress, modernity and research while maintaining the absolute highest standards of medical legal death investigation to the people of Ada County, and remaining an active partner in the community in which they serve.

In addition, the candidate must be skilled in performing autopsies and examining human bodies, providing expert testimony and advising the Prosecutors office in criminal proceedings relating to deaths.

Knowledge of firearms and other instruments of death, vehicular crash analysis, and rules of evidence and court procedures will be a vital asset in this candidate. In addition, the candidate would possess knowledge of criminal investigation methods and techniques and crime scene processing. Knowledge of Federal, State and local laws related to the operation of the Ada County Coroner's Office would be beneficial to the applying candidate.

The ability to respond effectively in a stressful emergency or crisis situation and to deal with people in a sensitive manner, is a unique and important part of this position. Candidate would willingly participate in peer review, covering for testimonies, and sharing daily case loads if necessary. Must be able to be available during established on-call hours.
