  - 1. A current, valid California Embalmer's License; OR,
  - 2. One (1) year full-time work experience working with a medical examiner/coroner's office, assisting with autopsies, which involved frequent direct contact with deceased persons, **OR**,
  - 3. One (1) year full-time specialized applicable experience which demonstrates possession of the required knowledge, skills, and abilities above (e.g., occupations such as medical technicians, medical laboratory technicians, hospital technicians or mortuary technicians that include the handling of human remains).
