Under general direction, performs work of considerable difficulty in post mortem examinations to determine the cause and manner of death and, if necessary, assists law enforcement in the identity of deceased persons.

**Major Duties, Responsibilities**

- Performs timely post mortem examinations, retaining samples, specimens and tissues necessary for analysis, examination and documentation in accordance with applicable laws and standard practices of forensic pathology.
- Prepares written autopsy reports opining the cause and manner of death; prepares and maintains records, reports and other documentation as well as physical evidence.
- Confers with law enforcement officials and attorneys in criminal cases and provides expert testimony.
- Assists with the preparation and administration of the operational budget.
- Performs other job-related duties as required.

**Expectations:**

- To ensure compliance with all legal requirements of a Medical Examiner's Office, including compliance with NAME Forensic Autopsy Performance Standards.
- To assist in developing long term plans for the department and to anticipate resources needed.

- To establish and maintain effective working relationships with employees, local law enforcement agencies, government officials, and the public.
- Maintain current knowledge of state and federal regulations governing death investigations.
- Communicate clearly and concisely both orally and in writing. Must be able to organize, interpret and present technical data in a manner understandable to non-technical staff and the public.

**Minimum Qualifications****Experience:**

A minimum of five (5) years' pathology/forensic experience.

**Education:**

Arizona MD/DO license required. Must be Board certified in Forensic and Anatomic Pathology.

**Other Skills****Other Skills:**

Must be able to stand for prolonged periods of time; lift and carry up to 50 pounds; push/pull up to 150 pounds; perform repetitive motions (elbow/shoulder); demonstrate visual acuity (near and far) for examinations and paperwork; demonstrate hearing and speech for ordinary conversations. Considerable knowledge of pathology and forensic pathological procedures, law, statutes and policies relating to post mortem examinations, human anatomy and autopsy procedures and safe and proper handling of body fluids, tissues and other body parts.
