Job Requirements (in particular board certification) Degree: Doctor of Medicine or Doctor of Osteopathy from a school in the United States or Canada approved by a recognized accrediting body in the year of the applicant's graduation. A Doctor of Medicine or equivalent degree from a foreign medical school that provided education and medical knowledge substantially equivalent to accredited schools in the United States may be demonstrated by permanent certification by the Educational Commission for Foreign Medical Graduates (ECFMG) (or a fifth pathway certificate for Americans who completed premedical education in the United States and graduate education in a foreign country).

**Specialized Experience:** Completion of an ACGME fully accredited residency training program in Anatomic or Anatomic and Clinical Pathology and a fully accredited ACGME fellowship in Forensic Pathology. The candidate must be Board eligible in Anatomic Pathology/Forensic Pathology.

**Workload:** This position's duty station will be housed within the Consolidated Forensic Laboratory (CFL) which is a protection sensitive facility. As such, incumbents of this position shall be subject to criminal background checks, background investigations, and mandatory drug and alcohol testing as applicable.

**Benefits:** This position is in the collective bargaining unit represented by Compensation Unit 19, Doctors' Council of DC, and you may be required to pay an agency service fee through direct payroll deduction. Selectee will be eligible for health and life insurance, annual (vacation) and sick leave and will be covered under the District of Columbia government's retirement plan. Employees who are assigned to tours of duty that include: Evening and Night: (10%) for regular scheduled work performed between 6:00pm and 6:00am. Sundays: (25%) for full-time employees for regularly scheduled hours worked on a Sunday. Call-Back-Pay a minimum of (4) hours overtime work shall be credited to any unit employee who is called back to performed unscheduled overtime work. A bargaining unit employee on a regularly established on-call schedule shall be compensated at a rate of (40%) of his/her basic rate of pay for each hour the employee is scheduled for on-call. Employer shall increase the reimbursement for each bargaining unit doctor from \$750.00 per fiscal year to \$1500.00 per fiscal year.
