What's the job description?



In this job, you'll:

- Complete post-mortem examinations (4 to 5 days each month, on average).
- Supervise, train, and mentor OME staff members, medical students, and forensic pathology fellows.
- Participate in DHHS leadership responsibilities, including providing input on policies and development that affect forensic medicine in Utah.
- Be a media spokesperson for the OME, as needed.
- Provide testimony as an expert witness in courts of law, pre-trial reviews, and other proceedings.
- Educate medical students, pathology residents, law enforcement, legal personnel, and other professional groups about forensic medicine.

Minimum qualifications:

- Have a current unlimited license to practice medicine in the State of Utah, or the ability to obtain this license before beginning employment.
- Board-certified as a Forensic Pathologist by the American Board of Pathology (ABP).
- Board-certified in Anatomic Pathology or Anatomic/Clinical Pathology by ABP.
- At least 2 years of experience practicing full-time forensic pathology.

Special considerations:

- An ABP certification in neuropathology, cardiac pathology, or pediatric pathology.
- Excellent verbal and written communication skills.
- Interested in teaching or academic research.
