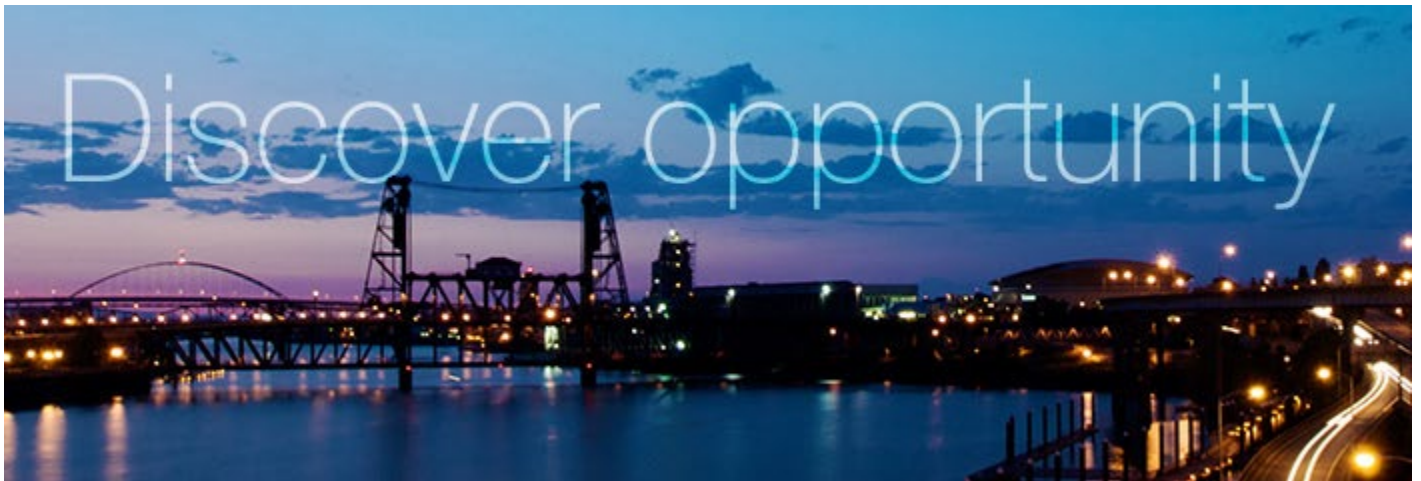

The Oregon State Medical Examiner is seeking two full-time forensic pathologists in our facility in Clackamas, Oregon, a suburb of Portland.

Big city excitement and small-town charm make Portland, Oregon, known as "the City of Roses", one of the favorite destinations in the West. Portland is situated approximately 70 miles from the Pacific in a magnificent setting between the sparkling waters of the Columbia and Willamette Rivers. Portland's historic old town, galleries and museums, Saturday Market, and theatre companies provide activities and entertainment for residents and visitors! Its lush green parks are perfect for a picnic or an afternoon stroll. Also, Portland is just a short distance from Willamette valley wineries, skiing at Timberline Lodge and all the excitement and beauty of Oregon's spectacular ocean beaches.

Portland's award-winning mass transit system is one of the most extensive and advanced in the U.S. The transit system includes buses, streetcars, historic trolleys and the MAX, an urban light rail line which provides service to metro area locations, including the Portland suburbs.



Portland was built with walking in mind. The short blocks, combined with public art and old-fashioned statuary, fountains, bridges and parks offer opportunities for leisure and contemplation for the casual stroller. Walking tours of the downtown area focusing on the best of the city's art, architecture, urban parks, and fountains are available. The city also features an extensive network of bicycle lanes and streets, supporting a green lifestyle. Portland has many green spaces, one of the highest of any US City. Forest Park is Portland's largest city park and one of the largest in the United States. At over 5000 acres, it has over 70 miles of trails for all skill levels.

Nightlife in Portland is excellent and varied. This includes the world class performances of the internationally known Oregon Symphony. Performing arts in the area offer ballet, Shakespeare, Broadway musicals, and modern dance. Portland is a common stop for touring bands and stand-up comics. Oregon Zoo concerts are a summer treat, with music for all kinds of listeners. See art up close at the First Thursday art gallery walks in Westside Portland or in Northeast Portland galleries during Last Thursday walks. Portland has many local pubs and breweries and a nationally recognized dining scene. For basketball, hockey, and soccer fans, the Rose City is the home of the Trail Blazers, Winterhawks, and Timbers!

Oregon has become one of the most popular relocation destinations for Americans. Oregon features a diverse geography that includes forests, mountains, beaches, and deserts. There are ample opportunities to enjoy Oregon's natural beauty, many of which are within one to two hours of the Portland Metro area. Cities like Astoria, Florence, and Bend are great places to plan weekend getaways.

The Medical Examiner Division is responsible for supervising 36 county offices in the investigation of unattended, unusual, and traumatic deaths. Personnel work closely with county medical examiners and medical legal death investigators. Autopsies are performed in three locations in the state. All medical legal autopsies in Northwestern, Eastern and Central Oregon are currently performed by pathologists in the Clackamas Office. However, the program is expanding with planning currently underway for a new facility the central Willamette Valley. The teaching program provides regular lectures on legal medicine and death investigation to many groups, including students from Oregon Health and Science University (OHSU) and Western University School of Osteopathic

Medicine, law students, pathology residents, medical legal death investigators, police officers, and healthcare professionals.

Drug analysis is done on-site by toxicology section of the Oregon State Police Forensic Services Division. The Medical Examiner's office has an on-site Lodox scanner. The medical examiner division employs a full-time forensic anthropologist who also manages the human identification program. Odontology and neuropathology consultations are available. The medical examiner division shares a building with a full-service forensics lab which can provide consultation services on complex cases.

These positions will split their time between our Clackamas facility and remote work. Current planning includes exploring renovations for our main facility to accommodate more office space as well as renting additional office space in the Clackamas area.

#### **DUTIES & RESPONSIBILITIES:**

- Performs autopsies and provides expert medical consultation in appropriate cases.
- Shares autopsy responsibilities with the State Medical Examiner and other Deputy State Medical Examiners in order to provide weekend, night, and vacation relief.
- Writes autopsy reports and other reports, as appropriate, related to a death investigation.
- Provides training, as requested, to law enforcement agencies, county medical examiners, district attorneys, and medicolegal death investigators

#### **Working Conditions**

Occasional overnight travel. Court appearances, communication with grieving relatives of the deceased, and calls during off-duty hours. Requires occasional lifting and exertion for short periods.

#### **QUALIFICATIONS, REQUIRED & REQUESTED SKILLS:**

##### **Qualifications:**

- Board certification or qualification for certification in anatomic or clinical/anatomic pathology from the American Board of Pathology (ABP) at time of hire.
- Board certification in forensic pathology within two years of hire.
- Licensed to practice medicine in Oregon or the ability to obtain a state medical license at time of hire.

##### **Preferred Skills:**

- Must be able to work cooperatively, cheerfully, and respectfully with other members of the medical examiner team.
- Must have good communication skills and be able to work effectively with other agencies.
- In addition to carrying an equitable share of the office caseload, it is expected that the successful applicant will assist in teaching pathology residents and medical students.
- Experience crafting and executing policy recommendations and/or participation in quality assurance activities
- On occasion, take part in public outreach in the form of lectures or conference attendance on behalf of the office.
- Must, at all times, exhibit the utmost respect for the decedents entrusted to our care.
