NOTES

CODE OF CONDUCT

1. The Code

As a means to promote the highest quality of professional and personal conduct of its members, the following constitutes the Code of Ethics and Conduct which is endorsed and recommended to be adhered to by all members of the Association:

- A. Every member of the Association shall refrain from exercising professional or personal conduct adverse to the best interests and purposes of the Association or to the medical examiner profession.
- B. No member of the Association shall materially misrepresent his or her educational training, experience, area of expertise, certification, membership status within the Association or official title or position in a medicolegal system.
- C. Every member of the Association shall refrain from providing any material misrepresentation of data upon which an expert opinion or conclusion is based.
- D. Except for the President and Chairperson of the Board of Directors or their designees, no member of the Association shall issue public statements that appear to represent the position of the Association.
- E. All applicants for membership and annual renewal of membership shall affirm by their signatures that they have read, understood, and endorsed the Code of Ethics and Conduct in this Article X.

MEDIA POLICY AND PROCEDURE

<u>Background:</u> Deceased patients are entitled to the same respect for the confidentiality of their personal information after death as they were in life. NAME Members have a responsibility to protect patient information, including investigative notes and medical records, in accordance with Federal, State, and jurisdictional laws when discussing case material.

NAME Members, when speaking to the media, are reminded their opinions do not represent the opinions of NAME. If a member is approached by the media to provide a statement on behalf of NAME, the member should decline request, obtain the name, and contact information of the reporter and immediately notify NAME's Executive Director for further guidance.

<u>Meetings</u>: The media/press can register and attend our annual and interim meetings. Media will be required to wear badges stating their name and affiliation. Their badges will have a yellow bar across the top of the badge which state "Media".

Absolutely NO photography, videography or audio recordings will be permitted unless otherwise authorized by a presenting author [i.e., QR codes]. Anyone in violation will be instructed to leave the meeting.

Member responsibility:

- 1. Each NAME member should be aware that media may attend our meetings and members need to understand that any comments made during the meeting should be considered "on the record" and do not represent the opinions of NAME.
- Media will also be reminded that comments made by NAME members do not represent the opinions of NAME.
- NAME members should be mindful that names of presentations and abstracts are available to meeting attendees, including the press and may want to assure a respectful tone in topic names and abstract information.






THE NATIONAL ASSOCIATION OF MEDICAL EXAMINERS

The National Association of Medical Examiners began, as many great organizations do, from the dreams, ideas and wisdom of a few farsighted, socially conscious individuals. Back in 1965, Milton Helpern recognized the need for the nation's Medical Examiners to share their knowledge, expertise and experience in order to improve the medicolegal investigation of death in this country.

He discussed this concept with Richard Childs, the Executive Director of the National Municipal League, and a group of his close colleagues, Ali Hameli, Chief Medical Examiner, State of Delaware, Leslie Lukash, Chief Medical Examiner, Nassau County, New York, and Joseph Spellman, Chief Medical Examiner, City of Philadelphia. In the spring of 1966, these individuals formed a planning committee in order to bring Doctor Helpern's concept to reality. This group became the foundation and heard of what was later to become the National Association of Medical Examiners.

Through the dedication and efforts of these five men, N.A.M.E. was incorporated in August, 1966. Subsequently they invited Chief Medical Examiners throughout the country to meet in Doctor Helpern's Office. As a result of that meeting, an interim steering board was formed which later paved the way for the first annual membership meeting held at the Knickerbocker Hotel in Chicago in February, 1968.

Dr. James Gill is the Chief Medical Examiner of Connecticut, a past President of the National Association of Medical Examiners (NAME), and past Chair of the Forensic Pathology Committee of the College of American Pathologists (CAP). He is a practicing forensic pathologist and has faculty medical school appointments at Yale, University of Connecticut, and Quinnipiac University. He did his pathology training at Yale and Memorial Sloan-Kettering Cancer Center and his forensic pathology fellowship at the New York City Office of Chief Medical Examiner under Charles Hirsch. Prior to Connecticut, he was the Deputy Chief Medical Examiner for Bronx County. He has published two textbooks and over 140 scientific articles and book chapters on a variety of forensic pathology topics. He has interests in drug intoxication deaths, infectious disease, fatal complications of therapy, and proper death certification.
